Out of Home advertising includes:

- Roadside Billboards: both under and over 25m<sup>2</sup>
- Roadside Other: Bus/tram shelters, kiosks, bus/tram exteriors, phone booths, free standing panels, truck exteriors, vehicle wraps, and bike/walking billboards.

- Transport: Rail platform & concourse, bus interchange, bus/tram interiors, airport externals (precinct), airport internals, taxis
  - Retail/Lifestyle/Other: Shopping centres/malls/universities/office blocks /cafes/medical practices /other digital place-based inventory
  - Ambient advertising including (but not limited to) small TV or other displays are excluded.
- ☐ **Supplier Members** – non-voting Members who do not qualify as Media Owner Members.
- Business or activities must include:
- the provision of goods or services to Media Owner Members; or
  - otherwise support Media Owner Members, the Out of Home advertising industry or OMA's objects
- ☐ **Asset Owner Members** – non-voting Members who are engaged in landlord/leasehold/ head contractor type operations and generally deal with Media Owner Members by leasing or contracting to lease space and or structures and or other rights to Media Owner Members, for the purpose of Media Owner Members selling or managing those spaces/structures/rights for the display of Outdoor advertising.

MOVE membership is only available to members of the OMA.

The OMA Board will determine the qualifications for each category of Membership. Applicants for membership and their associates must not carry out or have any interests in any business, activity or undertaking which is inconsistent with the purposes, business, activities, and interests of OMA (as determined by the OMA Board), By completing and signing this Form you agree to accept admission to the category of Membership determined by OMA.

This application must be signed where shown, by the Applicant, and by a proposer and a seconder who must be current full and financial members of the Association. The proposer and the seconder need to be from two separate OMA member organisations.

Once the completed application form is received, the CEO of the OMA brings it to the attention of the Board either at its next scheduled meeting or via circular motion. Applicants will be notified, by the CEO of the OMA once the application is accepted by the Board. Applicants will be invoiced membership subscriptions. The applicant will be deemed a member of the OMA following receipt of payment of membership subscriptions and commence a twelve (12) month probationary period.

## JOINING FEES AND SUBSCRIPTIONS

### Media Owner Members

A one-off joining fee equivalent to the applicants first year's membership subscription plus GST is payable.

Media Owner Members will be assessed into the following subscription formula:

- Entry subscription of \$5,000 per annum, which shall apply to all Media Owner members.
- Where Media Owners report \$1 or more of net revenue, an additional minimum subscription of \$5,000 per annum (\$10,000 in total), which shall apply to all Media Owner members who had net revenue of less than \$300,000 (add GST) in the previous year.
- Members with revenue of \$300,000 or more (add GST) in the previous year, will pay the minimum subscription of \$10,000 per annum, plus:
  - 0.225% of revenue from \$300,000 to \$250,000,000; plus

- 0.204% of revenue over \$250,000,000.

The information provided by the applicant is that (subject to assessment) their annual revenue from relevant formats listed under the Category of Membership.

Please indicate your annual revenue on the form attached to this application (Attachment 1) to be forwarded confidentially to the OMA's accountants. OMA will facilitate your contact with its accountants Prosperity Advisers to complete the necessary verifications.

If your application is successful, the OMA Board may remit *pro rata* for part of the initial subscription depending on date of admission (Association financial year is January to December).

Signed authority to Industry Auditor (Prosperity Advisers) will be required after receipt of your application.

### Supplier Members

The subscription fee for membership of the Supplier category is \$5,000 per annum plus GST. There is no additional joining fee for Supplier members.

### Asset Owners

The subscription fee for membership of the Asset Owner category is \$10,000 per annum plus GST. There is no additional joining fee for Asset Owner members.

## Application Terms

I/we:

1. apply to become a Member of OMA on the terms and conditions set out in the Rules and this Form.
2. confirm that I/we have read and fully understand the contents of this Form.

4. agree to be bound by and comply with the terms of this Form and the Rules (as amended from time to time) if admitted as a Member, including without limitation the obligation to respect the Confidential Information and Intellectual Property of OMA.
5. acknowledge and understand that the Board of OMA reserves the right to accept or decline any application without giving any reasons and determine the category of my/our Membership at their entire discretion.

  - a. OMA with any revenue data as the OMA Board shall request monthly and otherwise from time to time (Data). Any such information provided shall be in the manner, format and with such inclusions and exclusions as the OMA Board shall determine.

- b. the Data to the Advertising Standards Authority for the purposes of collecting, analysing and publishing advertising industry turnover statistics and agree to be responsible for and ensure the accuracy of any such Data provided.
- 9. Acknowledge and understand that all new applicants in the Media Owner category must meet standards of reporting, for the purposes of both revenue homogeneity and subscription band assessments, and to meet this requirement all such applications must be accompanied by a signed authority to the independent Industry Auditors (Prosperity Advisers) allowing confidential access to and confidential reporting to the Association on, Outdoor industry revenue
  - a. From approved and reportable Outdoor formats only
  - b. For the last 5 years (or at least the last two); and if admitted
  - c. To undertake to continue to be so examined annually until a total of 5 years pre and post admission performance can be assessed.

The costs of such examination to be borne by the applicant, are non-refundable and are to be paid direct to APD Prosperity Advisers.
- 10. agree, that if I/we are admitted to any category of Membership, to fully comply with all the requirements of the Association Incorporation Act 2009 , any applicable Codes of Practice, bylaws, orders or decisions made under the Rules, any applicable legislation and any local authority requirements for every site in my/our portfolio including, without limitation, the requirements of any approval, consent or authorisation (including any resource consent).
- 11. indemnify OMA and its officers, employees, agents and representatives from and against any and all liabilities, claims, demands, proceedings, actions, damages, losses, costs and expenses suffered or incurred by OMA (including direct or consequential loss and legal costs incurred on a solicitor and own client basis) arising directly or indirectly from any failure to comply with clause 9 above.
